Hazard Mitigation Grant Program

The Hazard Mitigation Grant Program (HMGP) provides financial assistance to States and local governments to implement long-term hazard mitigation projects following a Presidential disaster declaration. The State of South Dakota has approximately \$1 to 2 million available to be spent on disaster mitigation projects in the state. HMGP will pay for 75% of the total project costs. Eligible applicants include units of governments, tribal governments, and certain private non-profit organizations or institutions, such as REA's and Rural Water Association. Projects must provide a long-term solution to a problem and funds may be utilized to protect either public or private property. HMPG Plans are eligible and other eligible HMGP projects may include, but are not limited to:

- Acquisition and relocation of structures from hazard-prone areas, including acquisition of private property from willing sellers and demolition or relocation of buildings to convert the property to open space use.
- ☑ Retrofitting structures and facilities to minimize damages from floods, landslides/erosion, high winds, wildfires, earthquake, or other natural disasters.
- ☑ Structural hazard controls such as debris basins, floodwalls, riprap; or wetland restoration.
- ☑ Storm water or infrastructure protective measures.

Applications are due in the middle of January and are generally not the quickest to develop. If you are interested in this opportunity, please contact the Central SD Enhancement District as soon as possible. The District will assist with applications.

Current Income and Net Worth Qualifications to Purchase a Governor's Home



- Household income cannot exceed \$44,660 for couples or individuals and \$51,040 for families of three or more subject to change.
- For families and individuals under the age of 62, net worth must be less than \$90,000 and less than \$70,000 in liquid assets.
- The house must be placed within South Dakota and be owned by the individual(s) living in the home.
- The house must be used as the homebuyer's only residence
- For families and individuals age 62 and older, net worth must be less than 175,000 and less than \$100,000 in liquid assets.
- The house must be placed within South Dakota and be owned by the individual(s) living in the home. There is a new narrow lot layout of the home designed for narrow lots in communities. Individuals and or Developers may contact Al or Marlene at the District for more information.

CSDED Income Statistics

According to StatsAmerica.org statistics, October, 2013, data saw the District 5-year Per Capita Money Income Average at \$27,481 while the US was at \$27,915. Yet the individual county statistics were as follows: Haakon County-\$29,162; Hughes County -\$29,628; Hyde County-\$25,301; Jackson County-\$15,721; Jones County-\$25,407; Stanley County-\$27,732; and Sully County-\$28,347. This shows 56.3% of the national average for Jackson County to a high of 106.1% for Hughes County.

Yet, according to the Bureau of Economic data, the District's 2011 per capita income ranged from \$31,408 in Jackson County to \$116,067 in Sully County. These were 75.5% and 279.28% of the national per capita income of \$41,560. Every county saw an increase in PCI from 2010 to 2011 with the greatest increase being Jones County by 48.6%. Jackson County is typically lower due to the number of natural disasters and the lack of jobs in the county. Hughes County saw the lowest growth of per capita income by 6.78% between 2010 and 2011 (adjusted for inflation), which was the only county below the average for the state which was 11.78%. The low growth of Hughes County's per capita income is most likely due to a freeze on state employee wages.

In relationship to South Dakota as a whole, all District counties saw a larger increase in PCI between 2010 and 2011 than the state and the nation. While this is a positive sign for the region's economy, continuing to diversify the job base will enhance our future.

Mark Fenton, Nationally Known Healthy Design Consultant, Discusses Making a Community Healthy through Sticky Design

Mark Fenton, nationally known and highly regarded public health, planning, transportation, healthy community design and walkability consultant, delivered a day long workshop on increasing physical activity through community design at the SD Healthy Stakeholders Meeting and a shorter presentation at the SD Parks and Recreation Association Conference, in Pierre on October 1st and 2nd. Fenton delivered a message that included real, take-home doable solutions for communities to increase active transportation – walking, biking, and use of public transit – in an effort to improve health, economic vibrancy, increase community connectedness, and create healthy, vibrant neighborhoods. He also led a walk audit at both sessions, taking participants for a brief walk through the community of Pierre to discuss and examine facilities and attributes that either contribute or reduce the overall 'walkability' of the area. The South Dakota Department of Health is currently working with a multi-disciplinary team throughout the state to promote walkability and active transportation in communities throughout the state.
